27-2019 APOLOGIES FOR ABSENCE All present.

28-2019 **<u>DECLARATIONS OF INTEREST</u>** Cllr T Pearce declared a personal interest in item 4 – Matters Arising - Church Car Park Toilets and Item 4 - Matters Arising - Proposed Housing due to his position as West Devon Borough Council Ward Member. Cllr B Lemon and Cllr D Percival both declared an interest in Item 4 - Matters Arising - Housing Survey as both have family members who have registered an interest.

- APPROVAL OF THE MINUTES OF THE COUNCIL MEETING HELD ON 11th February 2019 29-2019 It was AGREED that the minutes of this meeting be adopted.
- MATTERS ARISING FROM THE MINUTES NOT LISTED AS SEPARATE ITEMS ON THIS AGENDA 30-2019 Members **NOTED** the action tracker circulated with the agenda.
 - a) Church Car Park Toilets There are still many unanswered questions to be resolved before the Parish Council are willing to commit to take over the running of the toilets. It was unanimously AGREED and accepted by WDBC that the Parish Council will pay WDBC a sum of £1500 for them to continue to run the toilets until April 2020. This will give further time for the ALL details of the proposed transfer to be properly agreed. The payment will be made to WDBC in September and the church has offered £500 towards this expense. Clerk will also try again to organise a meeting with Mrs C Aubertin (WDBC). A date of 22nd March at 4pm has been suggested. Cllr D Percival will contact the locksmith who provided a quote to advise that we will be in touch again in September when the toilets are closed down for the winter.

 - d) Cemetery restoration and maintenance Cllr T Pearce had met with Belinda Wheeler who advised that the current contractor seems to be doing more work than was originally specified. She also raised concerns that the grass cuttings were being piled next to the hedge and should be removed, and suggested that the number of cuts should be reduced to 3 per year (April/May, July and Sept/Oct). It was AGREED that in order to proceed, a schedule of works needs to be drawn up. There is a general feeling that the cemetery looks uninviting at the moment and although sympathetic to the need to encourage wildlife etc, there must be a balance. Cllr B Lemon offered to take grass cuttings to the tip if others are willing to collect them and load them into his vehicle. Clerk to go through the original document from Belinda and list the main points. Cllr B Lemon happy to help with drafting a schedule of works.

Cllr T Pearce will make further enquiries about work needed to repair/replace the pillars.

e) Brentor Engine Nameplate – Cllr T Pearce will speak again to the late Mr Doidge's daughter to organise a suitable date to take the sign to the Plym Valley Railway. Cllr D Percival happy to accompany Cllr T Pearce.

40-2019 MINOR ITEMS

- a) Cllr L Bristow voiced her concerns following a recent hunt when 3 horses were cantering along the lane after the hunt had finished. One of the hounds also became separated from the pack and was seen wandering in the fields much later. It was felt that although it would be good practice for the hunts to let residents know in advance, there was little the Parish Council could do to enforce this.
- b) Cllr D Percival brought to the attention of the Parish Council, a wooden bench on the way out of the village in a poor state of repair. He will check further to see if there is an inscription on the bench and track down the owner.
- c) Cllr B Lemon is concerned about the number of HGV lorries travelling through the village and the potential damage to the cattle grids. These concerns have already been raised with Highways who have stated there is nothing that can be done to make drivers follow a particular route.
- d) Cllr T Pearce informed the Cllrs that moves are afoot to make St Boniface the Patron Saint of Devon due to his historical connections to the county.
